The establishment of a solid quality assurance system in the Republic of Moldova higher education institutions will continue to be an important guarantee that the study programs offered by higher education institutions meet the highest standards in terms of quality, education and research, the quality of education being an indispensable condition for improving the employment, cohesion social and economic competitiveness.

Being based on rigorous international standards, which comprise the entire portfolio of Bologna Process issues, the concept of higher education quality insurance is one of the main priorities of the academic community in the Republic of Moldova in the near future in order to ensure a high degree of international transparency which is meant to allow the recognition of university qualifications in the European Higher Education Area.

• The implementation of higher education reforms concerning the internal and external quality assurance requires a substantial effort from all actors in the process of developing a culture of quality throughout the national education system.

- At this stage, substantial efforts have been made in the field of external quality evaluations of undergraduate and master's degree programs, but the process of external quality evaluation has not started for institutional accreditations so far.
- The QFORTE project fits perfectly into the initiated reforms by involving many educational actors, such as rectors and vice-rectors, deans and vice-deans, heads of departments, internal and external quality assurance structures, students.
- QFORTE will seek to ensure that university policies are taken into consideration at national-level policy discussions on internal and external quality assurance. It will also support its members in developing internal quality assurance systems and aims to promote the institutional quality culture.

The key activities of the QFORTE project are expected to result in:

- international institutional accreditation of five national universities;
- improvement of the methodology of external quality assessment for institutional accreditation;
- external quality assessment of joint higher education programs based on the European experience in the field;
- development of quality guidelines;
- enhancing the capacity of internal quality assurance structures:
- promotion of the national quality culture.

I am firmly convinced that quality assurance leads to mutual trust, increased mobility and the proper functioning of the recognition of qualifications and diplomas within the EHEA, and the QFORTE project will make a key contribution to promoting the culture of quality at the national level.

## The first Consortium Meeting of the QFORTE project

## ❖ The first study visit within the QFORTE project of the Erasmus + Programme, supported by the European Commission

The first online study visit took place on 11-15 June 2021. The visit was organized by CEENQA / Germany and led by the National Agency for Quality Assurance in Education and Research (ANACEC). The rector of the Moldova State University (USM), PhD Assoc. Prof. Igor Sharov, the president of ANACEC, PhD., Assoc. Prof. Andrei Chiciuc and PhD Assoc. Prof. Olgun Çiçek the representative of the Central and Eastern European Network of Quality Assurance Agencies in Higher Education (CEENQA) inaugurated the first day of the visit.

The study visit examined good practices in external quality assurance from Slovenia presented by Nataša Kramar, Deputy Head of the Slovenian Quality Assurance Agency for Higher Education (NAKVIS), in Northern Cyprus presented by Olgun Çiçek and Germany presented by the project manager of the Accreditation **Programmes** for Study in Engineering, Agency Informatics, Natural Sciences and Mathematics (ASIIN) CEENQA Secretary General, Jan Philipp Engelmann. The head of the international department of NAKVIS, Klemen Šubic reported on how to transform an accreditation system from programme to institutional accreditation.

Finally, Jan Philipp Engelmann referred to the actions needed to keep programme and institutional accreditation side-by-side followed by a guided discussion on how to prepare for institutional accreditation.




# \* QFORTE Workshop National policies in the development of institutional quality assurance systems

On 30<sup>th</sup> of September, 2021, a workshop on national policies in the development of institutional quality assurance systems in a hybrid format (both online and offline) was held at the Moldova State University, attended by representatives of seven educational institutions: USM, ASEM, USARB, US Cahul, US Comrat, USPEE, AMTAP and the ANACEC. Also representatives of the external partners: University of Montpellier, France, University of Salamanca, Spain, University of Leipzig, Germany, European Institute for Policy Development and Research in Maribor, Slovenia and Network Central and Eastern European Quality Assurance Agencies attended the workshop online.

Also, there were invited other national universities. As a result, representatives of 11 non- partner universities joined the workshop and participated in discussions.



Mr. Igor Şarov, PhD. Assoc. Prof., rector of the Moldova State University mentioned that the concept of quality assurance of higher education is one of the main priorities of both the Moldova State University and the academic community of the Republic of Moldova in order to ensure a high degree of international transparency, meant to allow the recognition of university qualifications in EHEA. "I am convinced that this activity, even under hybrid conditions, will lead to the improvement of external quality assessment procedures for the purpose of institutional accreditation, as well as the obtaining of international institutional accreditations by national universities."


