Meeting of QFORTE project's national coordinators

On 28 January 2022, Moldova State University organized a meeting of the national partners of the QFORTE project. It was held online, due to Covid-19 restrictions, and was attended by QFORTE project members, representatives of working groups form partner universities from the Republic of Moldova: QFORTE grant coordinator, QFORTE institutional coordinators, Vice-Rectors for Education, Heads of QA Departments, QA officers. The main point of discussion was the elaboration of the institutional strategies and the action plans on quality assurance for the next five years. Each university representative made a presentation about the institutional legal acts on quality assurance.

The participants were asked to present general information about the existing documentation on the QA within each Moldovan partner university. Having presented the information about the QA documents, all partners agreed that there is an evident lack of a strategic institutional document that would cover all levels of an institution, with indicators of performance and detailed action plans.

Nadejda Velișco, QFORTE grant coordinator presented a PPT, containing information on the recommended format of the institutional QA strategy: structure and components by offering detailed description and requirements for each item. The strategy will be based on the concept of the university integrative function, which seeks to find solutions able to benefit all fields, sectors and actors of the university as a whole. Senates will be in charge of adopting university strategies once a consensus has been reached within the university.

Suggestions and recommendations on the elaboration of institutional QA strategies developed by WP3 Leader University of Leipzig and co-leader University of Salamanca were introduced to the meeting participants and discussed.

It was agreed that the draft version shall be finished by 25 March 2022, the final draft version by 15 May 2021 and institutional discussion and approval till 15 June 2022.

Study-visit to the University of Salamanca - a good practice activity on institutional accreditation within the QFORTE project

A study-visit to the University of Salamanca, Spain, hosted by the BISITE research group, within the project QFORTE was organized during the period of 8-10 November 2021. The event is an initiative promoted by the Erasmus+ Programme, co-financed by the European Union and coordinated by Moldova State University.

The purpose of the visit was to study and research the ways for improving the quality of studies in higher education institutions in the Republic of Moldova through strategies used in the European space, as well as the exchange of good practices on institutional accreditation. The meeting was held in hybrid format due to restrictions imposed by the COVID-19 pandemic.

Moldova State University was represented by dr. Irina Gîncu, Head of the Studies Department; dr. Georgeta Stepanov, Dean of the Faculty of Journalism and Communication Sciences and Violeta Cotilevici, Head of Curriculum Development Unit.

The program of the visit included topics on:

- Characteristics of the Spanish national quality assurance framework, national institutional accreditation procedures and external evaluation.
- Principles, process, and organization of the internal quality assurance process within the Spanish universities.
- Institutional quality assurance strategies of the University of Salamanca, the tools and methodology applied.
- Spanish experience in completing the process of accreditation of study programmes, but also of institutional accreditation.

The meeting was opened by Mr. José Miguel Mateos Roco, Vice-Rector for Research and Knowledge Transfer of the University of Salamanca, accompanied by Mr. Salvador Rus Rufino, Director of the Castilla y León Community Quality Agency and the Representative of the VISIT Group Mr. Juan M. Corchado Rodríguez with a greeting message.

evaluation, certification, and accreditation of all research fields and institutions, as well as the evaluation and certification of academics.

Mateos Roco, in his speech, emphasized that quality assurance has become a way to formalize the communication and to equalize different education systems, providing an adequate, stable, and secure framework for the exchange of knowledge, research and human resources.

Mr. Juan Manuel Corchado presented the quality assurance process at the University of Salamanca mentioning the innovation methodologies and the five steps for strategic innovation planning, followed by the ANECA representative who reported on the national accreditation framework in Spain and on the evaluation of Spanish higher education institutions. The procedure was described as a complex one, consisting of three stages: self-evaluation, a visit by a group of experts and evaluation for accreditation.

During the study visit, there were discussed the methods of evaluation and accreditation of higher education programmes (Cycle I - Bachelor, Cycle II - Master, Cycle III - Doctorate), institutional accreditation and teacher evaluation. In addition, the institutional system of surveys, suggestions and complaints were presented.

The study visit ended with a communication on the evaluation of scientific publications and the evaluation of research activities followed by a round table where good practices in the field of quality assurance were discussed.

Study Visit to the University of Montpellier within the QFORTE Project

On 18-22 October 2021, within the QFORTE project (Enhancement of Quality Assurance in Higher Education System in Moldova, reference number: 618742-EPP-1-2020-1-MD-EPPKA2-CBHE-SP) representatives from PCUs, Ministry of Education and Research, ANACEC visited the University of Montpellier, France. The main goal of the event was to ensure the transfer of the best practices of the University of Montpellier in introducing various models of QA strategy development at university level. It was mentioned that QA and the monitoring processes at the University of Montpellier are based on the holistic approach, being carried out within the implemented projects. International Relations and Ms. Celine Delacourt – Gollain, Head of International Relations Department welcomed the participants of the study visit and presented a short description of the University of Montpellier, the youngest medieval university. 
