

Survey response rate






2. The proposals of a new QA procedures on institutional accreditation are appreciated by the university QA departments:


3. The presentations of a new QA procedures on institutional accreditation in your institution were?


4. How long were the presentations of a new QA procedures on institutional accreditation in your institution?


5. The availability of a new proposals of a new QA procedures on institutional accreditation?


6. The information and assistance provided by institutional coordinator?


7. How well do you think the objectives and outcomes of the QFORTE project were achieved?


8. How much do you consider the QFORTE project has helped institutions to improve/consolidate their Internal Quality Assurance System?
